## **CONVERSION OF CONVERTIBLE NOTES**

On 19 September, 2016, the Company has received a formal request from our Noteholder holding RMB90 million Convertible Notes of the Company, to convert RMB50 million of its Convertible Notes into the Company’s Ordinary Shares and the Board of the Company has approved the conversion. Hence, 29,101,237 Ordinary Shares of the Company, represent approximately 1.33% of the issued share capital of the Company immediately before the conversion and approximately 1.32% of the issued share capital of the Company immediately after the conversion, will be issued to the Noteholder and RMB40 million Convertible Notes of the Company will be held by the Noteholder after the conversion.

Reference is made to the announcement of the Company dated 23 October 2013 in relation to the extension of maturity date of the Convertible Notes and the announcement dated 30 November 2010 and the circular of the Company dated 1 November 2010 (the “**Circular**”) in the relation to, among others, the issue of the Convertible Notes in an aggregate principal amount of RMB200 million. Capitalised terms used in this announcement shall have the same meanings as those defined in the Circular unless otherwise stated.

The Company announces that on 19 September, 2016, the Company has received a formal request from our Noteholder holding RMB90 million Convertible Notes of the Company, to convert RMB50 million of its Convertible Notes into the Company’s Ordinary Shares and the Board of the Company has approved the conversion. Hence, 29,101,237 Ordinary Shares of the Company, represent approximately 1.33% of the issued share capital of the Company immediately before the conversion and approximately 1.32% of the issued share capital of the Company immediately after the conversion, will be issued to the Noteholder and RMB40 million Convertible Notes of the Company will be held by the Noteholder after the conversion.

After the conversion carried out by the Noteholder, there would be in total an aggregate number of 2,211,898,756 Ordinary Shares and RMB40 million Convertible Notes in issue.
